VHA's Technical Career Field (TCF) Internship in Health Information Management (HIM) prepares interns for careers within the Department of Veterans Affairs (VA). Each intern works closely with an assigned preceptor who has real-world, career experience within HIM and expertise in areas such as privacy, records management, and VA's award-winning electronic health record system. Over the course of the two-year program, interns develop necessary knowledge and skills to move directly into HIM management positions.

Upon successful completion of the program, interns may be converted to one of the many HIM career-conditional or career appointments VA offers nationwide. Graduates of this program have moved directly into VA leadership positions including:

- ▶ Chief HIM
- ▶ Assistant Chief HIM
- ▶ HIM Specialist
- ▶ HIM Supervisor

HIM interns get Federal employment benefits such as:

Paid Federal holidays
Paid sick and annual leave (personal/vacation)
Health insurance

Why Become a Health Information Management Intern?

What can interns expect?

- ▶ Non-competitive placement in a VA job at the end of the internship with funded relocation
- ▶ Development of training plan with preceptor
- ▶ Travel

Interns are required to:

- ▶ Have a BS in Health Information Management or an AS in Health Information Technology
- ▶ Successfully sit for the Registered Health Information Administrator/ Technician exam during the first internship year
- ▶ Sign a mobility agreement

HIM interns enjoy Federal employment benefits, including:

- ▶ 10 paid Federal holidays
- ▶ 13 to 26 days of paid annual leave (personal/vacation) per year
- ▶ 13 days of paid sick leave per year with no limit on accumulation
- ▶ Retirement programs with matching contributions
- ▶ Health Insurance
- ▶ Federal Employee Government Life Insurance
- ▶ Flexible Spending Accounts (Medical)
- ▶ Child Care Subsidy

Additional HIM Internship program benefits:

- ▶ Two year full-time internship under a trained preceptor
- ▶ Salary funded for two years
- ▶ \$10,000 annually for tuition and travel for training (dependent on budget constraints)
